If your child(ren) is between the ages of 4-6, your child(ren) will participate in **Division 1** events

- 40-yard dash, baseball throw, standing broad jump, beanbag toss

If your child(ren) is between the ages of 7-8, your child(ren) will participate in **Division 2** events:

- 40-yard dash, baseball throw, standing broad jump, horseshoe toss

If your child(ren) is between the ages of 9-10, your child(ren) will participate in **Division 3** events:

- 70-yard run, soccer kick, standing broad jump, horseshoe toss

If your child(ren) is between the ages of 11-12, your child(ren) will participate in **Division 4** events:

- 70-yard dash, basketball shoot, running broad jump, shot put

If your child(ren) is between the ages of 13-14, your child(ren) will participate in **Division 5** events:

- 70-yard dash, basketball shoot, running broad jump, shot put

Following the individual events, 3 Team Events will take place: Town Obstacle Course, Tug of War, and Relay Team Race. Team event participants are randomly chosen from each age group and must participate in individual events to participate in the town events.

Rules:

- A signed registration form must be signed and turned by the 9th of September in order to
- Participants must sign up in his/her town of residence only.
- Boys and Girls compete separately except in town events.
- All participants must complete each individual event in order to participate in a town event.
- During town events only two coaches and no one else may be on the field with their team.
- **Sneakers must be worn** by all participants - **No Cleats Allowed and No Bare Feet**
- No booing — **Good Sportsmanship** is a must.
- September 23, 2017 is the cut-off date to decide which division a participant will be assigned to.
- Latex medical gloves are the only acceptable gloves for use in the tug-of-war.
- The tug-of-war rope cannot be wrapped around any body part.
- Participants in town events cannot trade town events with any participants. (unless approved by town rep)
- All decisions are made by the Jr. Olympic Committee and decisions are final.
